2. Prices are based on the local tariff at the time of quoting, converted at the prevailing foreign-exchange rate as determined by VTIT.

3. Price quotations are subject to change without notice, until a booking has been confirmed.

4. Unless otherwise specified, prices do not include any local taxes or use-fees, including foreign departure, security, port charges, park fees, customs, immigration, agricultural, passenger-facility charges or international transportation tax.
